



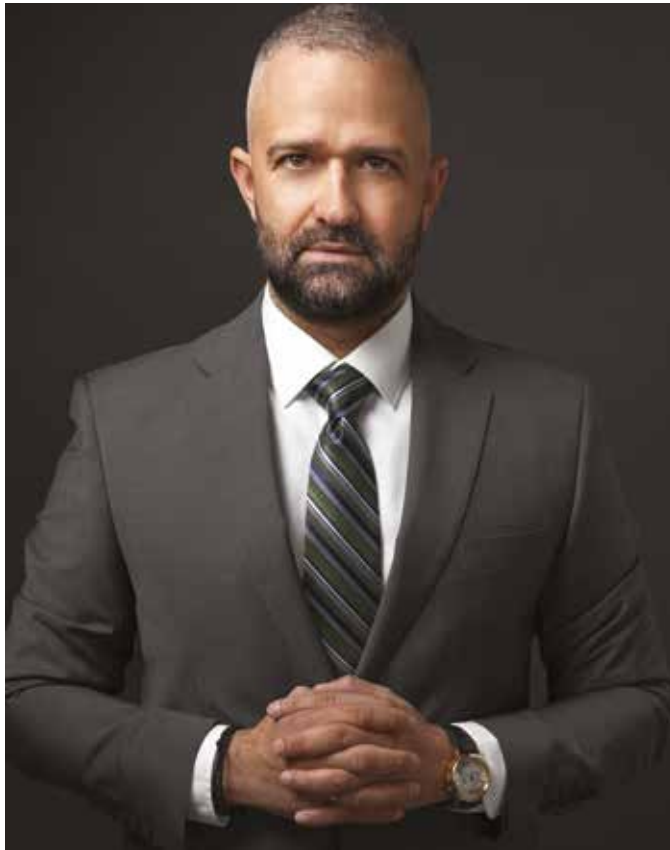

Cyprus as a Destination and a hub for Investment

Cyprus has emerged as a leading investment fund center in Europe, attributed to its early adoption of the Alternative Investment Fund Managers Directive and the enactment of the Cyprus Alternative Investment Funds Law. The country offers direct market access for investment funds and asset management companies. Cyprus boasts around 300 investment funds and more than €11.6bn in assets under management as of the third quarter of 2024. As an EU member, Cyprus adheres to all EU Directives and Regulations.

1.

Real Estate

The real estate boom in Cyprus reflects a robust economy and a favorable investment environment, attracting both domestic and international buyers. In the last couple of years, there is a noticeable increase in both local and foreign investments. Statistical data from the first quarter of 2025 shows a surge in property sales across the country, particularly in popular locations like Limassol, Paphos, and Larnaca.

The demand for residential properties, including apartments and villas, has been steadily rising, driving property prices upward. Additionally, the commercial real estate sector is also flourishing, with a rise in office spaces, retail outlets, and hospitality establishments being developed to cater to the growing market needs. The expansion of the tourism industry in Cyprus has further fueled the growth of the real estate sector, with investors eyeing lucrative opportunities in the hospitality and short-term rental markets.

2. Tech & Innovation

We recognize that choosing the right location for your international or regional headquarters is critical. Cyprus is rapidly emerging as a leading destination for technology-focused companies and multinationals. With a flourishing tech cluster already home to numerous flagship companies, Cyprus provides all the essential resources for setting up headquarters, launching regional offices, or nurturing innovative start-ups. Cyprus is recognized for its expertise in software development, systems integration, testing services, research and development, and more—servicing clients across high-growth markets. Attractive incentives, including a favorable IP regime and government support for the tech sector, make it an ideal locale for innovation.

3. Green Energy

Aligning with EU policies on reducing greenhouse gas emissions from power generation is a top priority for Cyprus. The country is expected to experience significant growth in Green Energy Sources (GES) due to the impending liberalization of the electricity market. In 2020, renewable energy technologies accounted for approximately 12% of the electricity generated in Cyprus. The country aims to increase the share of renewable energy sources to 23% by 2030 and plans to generate 25% to 40% of its electricity from solar power by 2030 as per the Cyprus Renewable Energy Roadmap (CERA).

Tourism & Hospitality

The tourism and hospitality industry significantly contributes to Cyprus' economy, with a GDP share close to 15%. The country continues to attract investment from leading groups and hotel chains, leading to significant developments such as new marinas, golf resorts, hotels, luxury resorts, and an integrated Casino Resort. Cyprus remains an established and resilient tourist destination, with ongoing projects boosting tourism-related investments.

Higher Education

Cyprus offers a diverse range of accredited undergraduate and postgraduate programs at competitive costs. With three public universities, seven private universities, and over 40 public and private higher education institutions, Cyprus attracts numerous international students annually. The country prioritizes research, with a high absorption rate of EU research grants, making academic and scientific endeavors a core focus within Cyprus' higher education sector.

The Blue Economy offers great investment potential in line with positive and growing trends. The Maritime Spatial Plan of Cyprus and the relevant legal framework aims to maximize the growth potential of the island's marine waters (territorial sea and Exclusive Economic Zone) in a sustainable way. It encourages investments in the marine waters of Cyprus by creating predictability, transparency and clearer licensing rules in areas such as coastal and maritime tourism, aquaculture, ports and marinas, blue renewable energy (offshore, inshore and nearshore of clean and renewable power), fisheries, blue tech and ocean observation, water management.

8. Shipping

Cyprus is a leading maritime cluster encompassing the full range of shipping related activities. It is the largest third party shipmanagement centre in Europe - among the top 3 in the world - and a quality shipping registry. The richness of technical and legal expertise of the maritime workforce, the package of fiscal incentives coupled with an efficient and reliable 24/7 service, make Cyprus an attractive and competitive shipping destination.



9. Yachting

Cyprus presents a prime opportunity for yacht investment due to its robust maritime infrastructure with top-notch marinas, the favorable tax and legal framework, its proximity to popular cruising destinations and with an ideal climate providing optimal conditions for yachting year-round.

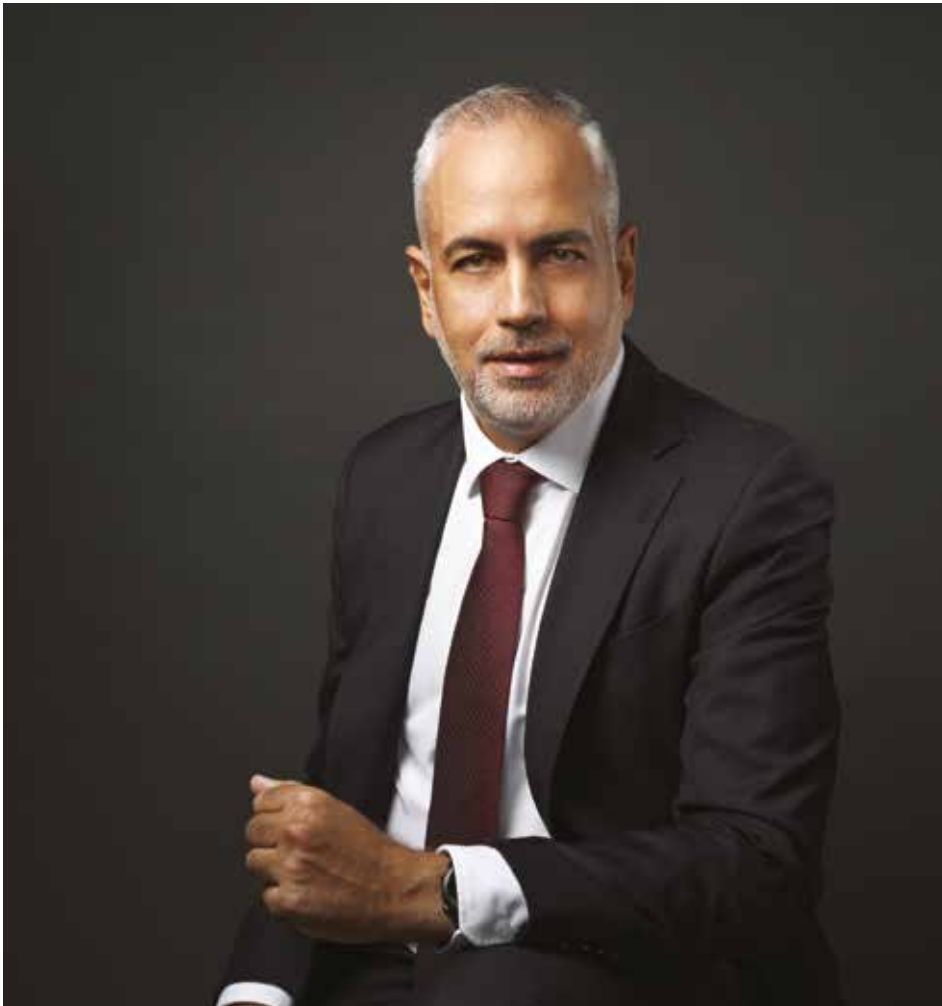
